Application requirements Application requirements

To qualify your dream (an innovative solution, project or initiative) must aim to tackle a local or social issue in Australian communities, and the business receiving the grant must also be:

- a registered Australian Business
- based in Australia with funds being spent in Australia
- a small to medium sized business with less than 200 employees
- able to be undertaken in the next 12 months

If a dream is shortlisted (top 10), the business owner will be asked to provide the following documents by 13 September 2018

- ABN
- Registered Business Address
- Office address (if different from registered business address)
- Letter signed by an accountant to verify
 - The entrant is small to medium sized business and has between 1 to 200 employees
 - The small or medium sized business has been trading for 18 months prior to 1 August 2018
 - Last Financial Year Earnings Before Interest and Taxes (EBIT)
 - Previous year net cash flow
 - Latest balance sheet
 - Projections of the Profit + Loss and the cash flow (high level) for the next 3-5 years
